Minutes Floyd County Board of Supervisors September 26, 2023

- 1. Called to Order Chairman Turman called the meeting to order at 6:00 p.m.
- 2. Opening Prayer The opening prayer was offered by Supervisor Cox.
- 3. Pledge of Allegiance Supervisor Kuchenbuch offered the Pledge of Allegiance.
- 4. Quorum Dr. Millsaps called the roll. A quorum was found for all Supervisors.
- **5. Approval of Agenda** On a motion by Supervisor Kuchenbuch, seconded by Supervisor Bechtold, and unanimously approved the agenda of September 26, 2023.
- **6. Approval of Disbursements** On a motion by Supervisor Boothe seconded by Supervisor Kuchenbuch and carried unanimously the approval of both sets of disbursements as presented.
- 7. Approval of minutes On a motion by Supervisor Cox, Seconded by Supervisor Bechtold and unanimously carried as amended to approve the minutes of 09/12/2023.
- 8. Presentations
 - a. Lisa Baker, Commissioner of Revenue Re-assessment

Mrs. Baker reviewed the re-assessment schedule with the board. She noted that it takes approximately a year and a half to complete.

Supervisor Bechtold asked if one of the Assessors had a minimal challenge rate. Mrs. Baker said yes.

Also, discussed a possible cost decrease in the cost of one of the bids as long as it does not affect Mrs. Baker's department and the results in any way.

Mr. Cox asked if in the past we were able to negotiate the fee. Mrs. Baker stated that she believes the prior County Administrator did negotiate somewhat.

Also, a discussion ensued regarding the equalization board and the implications and timing of land use.

Mrs. Baker continued to update the board on the process and history of the process.

The board thanked Mrs. Baker and her team for all they have done and continue to do.

b. David Clarke - Virginia Department of Transportation

i. High School Road Abandonment

Mr. Clarke stated he has no update at this time, and we are awaiting the draft resolution from Alex at VDOT. Upon receipt, the County Administration will forward it to the County Attorney.

ii. Buffalo Vista Road

As of right now, it shows as a discontinued road. A conversation ensued regarding the resident and what his rights are as the property is presently deemed.

iii. Pioneer Way

Request for a stop sign and 15 MPH for safety purposes. Mr. Clarke stated he would check to see if a speed limit is established there.

iv. The speed limit on Route 8 (North of Town)

A Realtor asked if the board would entertain reducing the speed near the brewery for future development needs. Mr. Clarke noted that VDOT normally does not change speed limits to accommodate entrances. Also discussed removing the 45 MPH altogether and moving the 35 MPH pass the dumpster.

Mr. Clarke shared that they just did their equipment check as a dry run for the winter season.

Supervisor Boothe thanked the VDOT team for the work on Laurel Branch.

10. Old Business

a. Opioid Abatement Authority

Dr. Millsaps discussed the Gold Standard and noted that the Board already approved the Resolution for the Opioid Abatement Authority. Dr. Millsaps read the requirements of the application now needed in addition to the resolution already approved with regard to the Gold standard.

On a motion by Supervisor Bechtold and seconded by Supervisor Kuchenbuch to authorize the County Administrator to sign the Opioid Abatement Authority Application.

b. RFP Re-Assessment

§ 2.2-3711 A.1- Discussion, consideration, or interviews of prospective candidates for employment; assignment, appointment, promotion, performance, demotion, salaries, disciplining, or resignation of specific public officers, appointees, or employees of any public body; and evaluation of the performance of departments or schools of public institutions of higher education where such evaluation will necessarily involve discussion of the performance of specific individuals. Any teacher shall be permitted to be present during a closed meeting in which there is a discussion or consideration of a disciplinary matter that involves the teacher and some student, and the student involved in the matter is present, provided the teacher makes a written request to be present to the presiding officer of the appropriate board. Nothing in this subdivision, however, shall be construed to authorize a closed meeting by a local governing body or an elected school board to discuss compensation matters that affect the membership of such body or board collectively. Personnel update and Departmental Review.

§ 2.2-3711 A.8 - Consultation with legal counsel employed or retained by a public body regarding specific legal matters requiring the provision of legal advice by such counsel. Nothing in this subdivision shall be construed to permit the closure of a meeting merely because an attorney representing the public body is in attendance or is consulted on a matter. Emergency Management
